## Message From Our CEO


Dear Valued Clients,

Despite being a challenging year for most businesses around the world due to the pandemic, we are blessed to be able to still carry on our business in the microfinance and automobile sector achieving phenomenal results which we have set out for ourselves.

**As of Dec 2020, we have SGD28.9 million in loans in our financing business and SGD2.1 million in our automotive business.** Each business is generating consistent returns every month and quarter respectively. Out of the SGD28.9 million in loans, the demographic deployment would be 70% in Singapore, 30% in Myanmar (trade financing) and 10% in Cambodia.

### Business Infographic As of 1st December 2020




